

TERMS & CONDITIONS SVP & MARVEL'S AVENGERS: ENDGAME PROMOTION

Full Terms and Conditions

1. The Promotion

- 1.1. The Promoter of the "Shell V-Power Avengers" promotion ("the Promotion") is Shell U.K. Oil Products Limited (as agent for Shell U.K. Limited), Shell Centre, York Road, London, SE1 7NA (the "Promoter").
- 1.2. The Promotion runs across participating Shell Service Stations in England, Scotland and Wales and is open for the below period (whichever arrives first):
 - 1.2.1. From 00.01 GMT on the 14th March 2019 to 23.59 BST on the 8th May 2019 ("Promotion Period"); subject to:
 - 1.2.2. while stocks of promotional scratchcards last. If a participating Shell Service Station runs out of stock of promotional scratchcards, the Promotion shall continue to run across all other participating Shell Service Stations that still have promotional scratchcards in stock during the Promotion Period. If a participating Shell Service Station runs out of stock of promotional leaflets, the Promoter will replenish the stock within 72 hours. While stocks last, Monday to Friday.
- 1.3. Between the dates of 00.01 GMT on the 14th March 2019 and 23.59 BST on the 8th May 2019 there will be 56 Daily Periods. Each Daily Periods run from 00.00 to 23.59 each day. Following each Daily Period, there will be a Daily Prize Draw. All valid entries between the dates of 00.01 GMT on the 14th March 2019 and 23.59 BST on the 30th May 2019 ("Headline Holiday Period") will also be entered into the Headline Holiday Prize Draw.

2. Participants

- 2.1. This Promotion is only open to residents of Great Britain (England, Scotland and Wales) aged 18 or over, excluding employees of the Promoter, their immediate families (defined as parents, children, siblings, spouse and life partners), or anyone else professionally associated with this Promotion.

3. How to Enter

- 3.1. The Promotion will run at participating Shell Service Stations. Details of the participating service stations are available at: www.shell.co.uk/win.
- 3.2. For the purposes of these Terms and Conditions, a **Qualifying Purchase** is the purchase of £30 or more of Shell V-Power fuel at a participating Shell Service Station (as defined in clause 3.1) in one transaction.
- 3.3. Upon making a Qualifying Purchase, a Shell staff member will scan and provide a promotional scratchcard (subject to availability). An entrant must scratch the card to reveal a unique 7 digit alphanumeric code, then visit www.shell.co.uk/win and enter their full name, contact number, email address, date of birth and unique 7 digit alphanumeric code to be entered into the relevant Daily Prize Draw and the Headline Holiday Prize Draw.
- 3.4. Entry on www.shell.co.uk/win does not have to be on the same day as the Qualifying Purchase but will still need to be within the Headline Holiday Period.
- 3.5. One entry per unique 7 digit alphanumeric code, entries will be counted.

4. Prizes

 - 4.1.5. 3 x Exclusive BMW Driving Experience for 2, consisting of one-night stay in 4* hotel (to be decided by the Promoter), based on sharing a double/twin room including breakfast, BMW Driving Experience, and £200 travel allowance. Track session 9th September 2019 from 8-2pm @ Brands Hatch.
 - 4.1.6. 6 x Goodwood Festival of Speed tickets for 2, consisting of a pair of general admission tickets for Sunday the 7th of July at the Festival of Speed, including Sponsor's Enclosure tickets giving VIP access to the Sponsors Enclosure, food and drink package in the sponsor's enclosure, a Shell host, a one-night stay in a 3* hotel accommodation for two with breakfast on Saturday the 6th of July, and £100 travel allowance.

 - 4.1.8. 6 x Marvel VIP Personal Shopping Experience, consisting of the opportunity for the winner and a guest to take part in a VIP shopping experience at Disney Store, Oxford Street on a Sunday before the 31st July 2019, subject to availability. The winner and their guest will be greeted by their own Disney Store brand ambassador to take part in the Disney Store Opening Ceremony and given a personal shopping tour of the store. The winner will receive a Disney Store Marvel themed goodie bag with an RRP of £50 and a £300 Disney Store gift card to spend in store. The winner and their guest will also receive their own exclusive Disney Store Opening Ceremony Key.  - 4.1.10. 7 x 4K TV Bundle, consisting of 1 x LG 43-inch Smart 4K television with HDR, 1 x LG Smart Blu-ray and DVD Player, and 1 x Marvel Studios' Avengers Blu-ray 3 movie collection (Avengers Assemble, Age of Ultron, Infinity War).
 - 4.1.11. 9 x Cinema Night Out, consisting of a £50 gift voucher for a cinema chain of the winner's choice in the UK, two-course dinner and non-alcoholic drinks for two people at a restaurant of the winner's choice up to £30 per person, and 2 x Marvel Studios' Avengers: Endgame T-Shirts.

Headline Holiday Prize

- 4.1.12. 1 x Family trip for 4 to Dubai, consisting of return flights for four to Dubai, a four night stay in a 5* Hotel with breakfast included, tickets for two days at Expo 2020 to see the future of hi-tech innovation, spend the day at IMG World of Adventure featuring Marvel attractions, experience the world-famous and hi-tech Dubai Fountain Show, Soar to

the top of the world's tallest technologically advanced building (the Burj Khalifa). In the event that the winner wishes to take the Prize with less than four people, the Promoter will provide additional prize elements to ensure the Prize is the equivalent value as for four people. - 5.12. **Family trip for 4 to Dubai Terms and Conditions:** The promoter of this competition has hired DJP Marketing & Promotions Ltd. To handle the complete fulfilment of the grand prize holiday. DJP Marketing & Promotions Ltd. is registered in the UK. Company Registration number 8065185 registered to address 107 Bell Street, London NW11L, England. The winner and their guest(s) must be in possession of a valid 5-year passport and must have a minimum of 90 days validity for the duration of the prize holiday. 7. Winner Notification

- 7.1. Winners will be required to respond within 14 days of initial contact. In the event that the winner does not respond within 14 days of initial contact, the Promoter reserves the right to disqualify that winner. In the event that a winner is disqualified, the Promoter reserves the right to allocate the prize to a reserve winner selected in the same manner. Reserves may have less time to respond.

8. Promoter Rights

- 8.1. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond the control of the Promoter which corrupts or affects the administration, security, fairness, integrity or proper conduct of this Promotion, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion, or invalidate any affected entries.
- 8.2. The Prizes are not transferable or exchangeable and cannot be redeemed for monetary value or for any other form of compensation. If for any reason a Prize is not available, the Promoter reserves the right to substitute another prize for it, in its sole discretion, of equal or higher value.
- 8.3. The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Promotion or accepting or using the prize, except for any liability which cannot be excluded by law (including personal injury, death and fraud) in which case that liability is limited to the minimum allowable by law.
- 8.4. If an act, omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these Terms and Conditions the Promoter will not be liable for any failure to perform or delay in performing its obligations.
- 8.5. The Promoter reserves the right to verify the eligibility of entrants. The Promoter may require such information as it considers reasonably necessary for this purpose and any Prize may be withheld unless and until the Promoter is satisfied with the verification.

9. Privacy Policy

- 9.1. The Promoter may collect and process the following personal data about Participants: name, contact number, email address, date of birth and county of residence.
- 9.2. The Promoter may use the information it collects about Participants in the following ways:
 - 9.2.1. To contact the winners in order to request that they participate in publicity arising from the Promotion in accordance with the Promoter's legitimate interests. The winner is under no obligation to participate and may decline this request. Participation is at the winner's discretion.
 - 9.2.2. To announce the winners of the Promotion on the Promoter's website and by providing the winners' name and county of residence in accordance with the Promoter's legitimate interests.
 - 9.2.3. To organise the management of the Promotion (including arranging receipt of and/or participating in the prizes) and communicating with Participants in relation to the Promotion in accordance with the Promoter's legitimate interests. The "legitimate interests" of the Promoter include the proper administration of the Promotion and compliance with these Terms and Conditions.
- 9.3. The Promoter will not keep personal data relating to Participants for longer than is necessary for the purpose for which it was collected. Data relating to Participants will be retained by the Promoter for a reasonable period after the Promotion closes to assist the Promoter in operating promotions in a consistent manner and to deal with any queries relating to the Promotion. Notwithstanding the above, the Promoter may retain Participants' personal data where such retention is necessary for compliance with their legal obligations.
- 9.4. The Promoter is the Data Controller in relation to processing personal data of Participants to the Promotion. The Promoter can be contacted by email at the email address: generalpublicenquiries-UK@shell.com.
- 9.5. The personal data that the Promoter collects from the participants may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for the Promoter. The Promoter will take all steps reasonably necessary to ensure that Participants' personal data is treated securely and in accordance with this clause and the General Data Protection Regulation including ensuring that the transfer is made subject to appropriate safeguards including the use of standard data protection clauses approved by the European Commission.
- 9.6. The Promoter has implemented technology and policies with the objective of protecting your privacy from unauthorised access and improper use.
- 9.7. Personal data provided by Participants will only be used in accordance with the Privacy Policy set out in this clause which is also made available on the promotional web page.
- 9.8. To exercise the right to (a) request to access, update, correct or delete any personal data, (b) object to or request the restriction or processing personal data or (c) request data portability in accordance with individuals' rights under the General Data Protection Regulation. - 9.9. Where Participants have given the Promoter consent to the specific processing of their personal data, they have the right to withdraw that consent at any time. The withdrawal of such consent will not affect the lawfulness of the processing of that personal data prior to the withdrawal of consent. - 9.10. Any changes to the Privacy Policy set out in this clause will be posted on the promotional web page. Participants should check back frequently to see any updates or changes to the Privacy Policy.
- 9.11. If a Participant is unhappy with the way in which the Promoter has collected, processed or handled their personal data, they can make a complaint to the Information Commissioner. 10. General

- 10.1. The full name and counties of winners will be available to view online at www.shell.co.uk/win from 13th June 2019.
 - 10.2. All entries must be made directly by the person entering the Promotion. Bulk entries from trade, consumer groups or third parties will not be accepted. Incomplete or illegible entries and entries which do not satisfy the requirements of these Terms and Conditions in full will be disqualified and will not be counted.
 - 10.3. If any provisions of these Terms and Conditions are judged to be invalid, illegal or unenforceable, this shall not affect or impact the continuation in full force and effect the remainder of the provisions.
 - 10.4. By entering this Promotion, entrants agree to be bound by these Terms and Conditions.
 - 10.5. The Walt Disney Company and each of their respective parent, affiliates, and subsidiaries (Marvel Studios) are not responsible for the Promotion, administration or execution of the Prizes.
 - 10.6. These Terms and Conditions are governed by English law and shall be subject to the exclusive jurisdiction of the courts of England and Wales.
