

**TERMS AND CONDITIONS FOR THE SHELL AND BATMAN V. SUPERMAN: THE DAWN OF JUSTICE
COMPETITION TO BE RUN IN THE REPUBLIC OF SOUTH AFRICA ONLY**

1. This competition will run from 14 March 2016 to 08 May 2016
2. To enter this competition, participants must purchase a Super Hero Combo at participating Shell Select or Shell Shops and SMS BvS followed by your name to 32210 (R1/SMS) or dial *120*32210# and follow the instructions (Standard Rates apply). Free SMS's and bundles do not apply.
